If you do not hold a current Public Liability Policy, a fee of \$ 44 will apply to your application. ◆ A 50% deposit will be required at time of site confirmation. This fee will be refunded if you provide notification of cancellation BEFORE 4pm 19th January 2019. ◆ Payment of deposit, or full payment, does not constitute acceptance of application. Please confirm with GISS after 7th January 2019 if your application is successful. ◆ Bump-in prior 5.00pm Thursday 14th February NO VEHICLE ACCESS TO TRADING AREAS FROM FRIDAY 9.00AM FRIDAY UNTIL 12 NOON SUNDAY. Bump-out is after 1.00pm Sunday 17th February 2019 ◆ Exhibitor Gate Passes (2 only included in site fee) will be posted to the address listed during week commencing 21st January 2019. ** Upon arrival at the Showground, please attend the Secretary's Office (beside the Grandstand) to ensure all details are completed. ** Please advise if this is a non-workable proposal. ◆ Electrical Notice. Any exhibitors intending to bring electrical equipment onto the Showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of yourself, your fellow exhibitors and the general public and is a requirement of the Workplace Health & Safety Act of 2011. The Act imposes very severe penalties in the event of non-compliance with its provisions. Any exhibitors that fail to comply will not be allowed to exhibit at the Glen Innes Showgrounds.
