CONDITIONS

- ◆ Your business is required to hold a Public Risk Policy with cover of **NOT LESS** than \$20,000,000, a copy of your **Certificate of Currency** is to be provided with your application for Trade Space. If you do not hold a current Public Liability Policy, an **Administration Fee of \$ 44.00** will apply to your application.
- ◆ A 50% deposit will be required at time of lodging your application. This fee will be refunded if you provide notification of cancellation **BEFORE** 4pm 10th January 2020.
- ◆ Payment of deposit, or full payment, **does not** constitute acceptance of application. Please confirm with GISS after 6th January 2020 if your application is successful.
- ◆ Bump-in **prior** 5.00pm Thursday 13th February **NO VEHICLE ACCESS TO TRADING AREAS FROM FRIDAY 9.00AM FRIDAY UNTIL 12 NOON SUNDAY**. Bump-out is **after** 2.00pm Sunday 16th February 2020
- ◆ Exhibitor Gate Passes (**2 only** included in site fee) will be available for collection during week commencing 10th February 2020** **Upon arrival** at the Showground, **please attend** the Secretary's Office (beside the Grandstand) to ensure all details are completed. ** Please advise if this is a non-workable proposal.
- ◆ **Electrical Notice**. Any exhibitors intending to bring electrical equipment onto the Showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of yourself, your fellow exhibitors and the general public and is a requirement of the **Workplace Health & Safety Act of 2011**. The Act imposes very severe penalties in the event of non-compliance with its provisions. Any exhibitors that fail to comply will not be allowed to exhibit at the Glen Innes Showgrounds. **Please check all your electrical equipment and leads BEFORE you arrive to avoid any issues or inconveniences.**
